### Procedure:

The changes need to be proposed for specific sections of the Constitution and Bylaws by a Life and higher donation category members, seconded by another Life and higher donation category member and then put for vote. A simple majority vote will decide whether a change is approved or not. If a change is not approved, the existing language in the HTA Constitution and Bylaws will stand. The results will be announced after each voting and recorded in the meeting minutes.

### Minutes:

- Meeting was called to order by the president, Hara Misra, at 10:30 A.M. in the HTA prayer hall. The starting of the meeting was delayed by 30 minutes from 10:00 A.M. due to lack of quorum.
- Constitution was reviewed and approved by the voting members with the following suggestions:

# Hindu Temple of Arizona

- Article 2:
  - Approved unanimously
- Article 3:
  - Approved unanimously with the following changes:
    - Change “Class” to “Category” **CHANGED**
    - Include honorary members instead of advisors **CHANGED**
- Article 4:
  - Approved unanimously with the following changes:
    - Resolve advisors conflict in articles 4.1.1 and 4.1.5. **CHANGED 4.1.1 “Advisors” to “honorary members”.**
    - Include honorary members in article 4.1.1 instead of advisors **CHANGED**
    - Also include the names of the sister organizations **SISTER ORGANIZATIONS are defined on the cover page of the Constitution and hence not needed.**
    - Change “Select from board” to “Elect from board” in sections 4.1.2 and 4.1.3 **CHANGED**
    - No issues in articles 4.2 and 4.3
    - Change “Selected” to “Elected” in article 4.4.4 **CHANGED**
    - Article 4.4.3 is in conflict with article 4.1.2 – May be a redundancy **REFERENCE to “President is elected from the Board” is deleted in 4.4.3**
    - Clarify president term as one or two years in article 4.4.3 **CHANGED the order if sentences to clarify this. President’s term is only one year.**
    - No issues in article 4.5
    - Clarify officer removal procedure in article 4.6 **CAN’T FIND THIS**
    - Change “In” to “If” in articles 4.7.2 and 4.7.3 **CHANGED**
    - Last sentence in article 4.7.4 should include committee **It is ALREADY there.**
    - Article 4.8 should include “As Appointed by Members”
- Article 5:
  - Approved unanimously with the following changes:
    - Article 5.1 should be consistent with article 9.2 in Bylaws with respect to “Treasurer Signature Consistency” **REWORDED the last sentence to clarify this – removed reference that two people should sign checks. .**
    - Change “Audit” to “Financial Review” in article 5.2 **CHANGED**
    - Clarify limitation on Board of Director spending **There is no limitation of the spending except those included in bylaws,**
- Article 6:
  - Approved unanimously with the following suggestion:
    - Include brief essence of Robert’s Rule in the appendix
- Article 7:
  - Approved unanimously
- Article 8:
  - Approved unanimously
- It was decided to have a follow-up general body meeting to review the proposed edits to constitution and review the bylaws. The date for the follow-up general body meeting will be decided by the board of directors at the next board meeting.
