ARTICLES OF INCORPORATION OF

Hindu Temple of Arizona (An Arizona Non-Profit Corporation)

LET IT BE KNOWN BY THIS DECLARATION:

That we, the undersigned, for the purpose of forming a corporation under the laws of the State of Arizona, join together to adopt Articles of Incorporation as follows:

ARTICLE I The name of the Corporation shall be Hindu Temple of Arizona.

ARTICLE II This Corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Arizona, as they may be amended from time to time.

ARTICLE III This Corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law exclusively for religious purposes. The main aims and objectives of this Corporation is the advancement of Hindu religion or faith and through religious activities and the maintenance of the doctrines and tenets of the said religion or faith and of the observance that serve to promote and manifest it including the provision and maintenance of a Temple or Mandir for the purposes of public religious worship and other religious and charitable purposes.

ARTICLE IV. No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax, or by a corporation to which contributions are tax deductible.


ARTICLE VII The incorporator of this Corporation is as follows:

Hindus refer to their religion as "Sanathana or the eternal Dharma" because it represents principles that hold good for all ages, circumstances and places. Dharma has a deeper and wider meaning than the word religion as it is generally understood. Dharma means to preserve or hold together. It is the essential nature of existence. People, things and in fact the entire cosmos all have their own Dharma. Hindus emphatically uphold that the essential nature of all things is divine and it is the Dharma of human beings to realize the divinity in them. In order to move towards this goal Hindus believe that one has to work selflessly, worship God devoutly and undertake intellectual studies of the sacred scriptures.

The sacred books of the Hindus can be divided into the following main categories: Srutis or revealed knowledge which include Vedas that are at least 4000 years old and Upanishads, Smritis or practical applications of eternal principles which include social, moral and ethical codes of conduct, Itihasas or epics such as Ramayana and Mahabharatha which includes the epic poem "Bhagavad Gita" the cream of the Upanishads and Bramha sutras which are a series of aphorisms interpreting philosophical teachings.

Hinduism is based on monoism though it seems that they worship thousands of Gods. The One is called "Bramhan", the Eternal spirit, the trilogy represents creation, preservation and destruction and the infinite others are just different forms of the same One. Most Hindus are idol worshippers, but in fact they are worshipping the formless One through the idol and not the form of idol itself.

Hinduism is, according to the famous Indian philosopher statesman and a past President of India Dr. S. Radhakrishnan, "a movement, not a position; a process, not a result; a growing tradition, not a fixed revelation. It is a theology, a philosophy, a social system and a way of life."
