#### Minutes:

Surinder Tuli, Secretary started the meeting at 11:0AM Sharp, and informed the members that we will start the meeting as soon as the quorum is reached. Our Election chair will announce the Quorum. In the meanwhile, he requested Kamal JI and her Bhajan Mandli to sing some bajans.

At 11:15AM, the election committee chair announced all the members of his Team Ravinder Aggarwal, Rohit Aggarwal and Sunil Garg. He informed the members that they should send their names and their email in the chat box.

At this time one of the members asked the election chair that did he know that he was a witness in a case that is going on, before he accepted the role of election chair? To which the Election chair replied that he has never been informed that he has been named as a witness in any case. Dr. Pradhan informed all members that this is not part of the agenda and we stick to the agenda only. Another member (a past secretary) wanted to know why we can't discuss this issue giving an example that he was forced to read an attorney letter in last AGM. Another past president drew attention to the difference between the two issues and explained why we should not entertain it any more

At this time Secretary suggested let us move to the agenda, requested the Election chair to confirm the quorum-Mr. Aggarwal confirmed that we have 48 families represented and OK to proceed.

The secretary informed the members that due to the Covid 19 starting in March 2020, we have been following State and CDC guidelines at the Temple. The board decided to conduct the AGM and Elections on Zoom and not skip the AGM/elections. We are using Zoom for such a big task for first time, so please be considerate. This meeting will be recorded.

He read the some rules that will be followed during the meeting:

- 3. One person speaks at a time; let the person speaking finish their thought. Please don't interrupt the person who is speaking.

The Secretary updated that the 2020 board has incorporated all the changes to the Bye laws approved in the last AGM held on September 23, 2019. The new Byelaws are posted on the Website. All the minutes of the meeting held during 2020, are also posted on the HTA website. Bundle of thanks to Mr. Ramchandra Ji for his help in documenting all the changes to the bye laws.

#### Secretary invited Vaibhavi Ji to give President's report.

Dr. Pradhan thanked all the members for attending the meeting. She stated that the board started with very ambitious plans for the new projects, such as renovation of kitchen and improving our Temple facility to serve the community. All the planning began in February, however, the COVID-19 Pandemic- a vicious virus, put us on hold. Due to the lockdown, our Temple had to be closed, however, since our Pandit ji's apartment on temple premises, so he could do everyday's rituals, such as Pooja and Aarti. To have a Priest's residence at the temple is a great thing. Vaibhavi JI thanked the Founder Members and all past presidents and their Board members for their vision to have priest accommodation on Temple premises.

We had to postpone our projects, however, in the face of adversity, the Board found an opportunity. We changed, we adapted new Technology and with Zoom we resumed our Regular Hanumanji's Pooja, Satyanarayan ji Pooja and Mata Jagran. This has become our new normal; we have started Sunday poojas, thanks to our Technology team. Some of the major accomplishments are:

- 1. We finished Parikarma project.
- 2. There were two large trees, which were damaging the Temple's foundation. We removed them and improved the appearance of South entrance
- 3. We installed security cameras.
- 4. This is the first time we celebrated Navratre ustav at the Temple. Every night we did Havan puja. In the morning we did Durga Pooja and Aarti. Thank you to all sponsors, we generated good funds for the Temple.
- 5. We appointed new Pandit ji who is a graduate of Maharishi Vedic College. He was also a professor there. He is invaluable asset to the Temple.
- 6. We renovated both the Priest's apartments.
- 7. Due to the generosity of our devotees and good money management we remain a float. We have \$100,000.00 in our savings account.
- 8. We reconstructed our mortgage and reduced the mortgage rate. Now we are saving \$250.00 per month. I want to thank a volunteer who helped us to do all paperwork for the Bank.
- 9. We received \$7500.00 forgiveness loan (possible).
- 10. \$25000.00 grant from Maricopa County. This application filing and paperwork was a very tedious job. We spent hours to fill out the application. And again a volunteer stepped in and helped us. Thank you.
- 11. The funds for the kitchen project are in our Special Project account to be used by next Board.

Vaibhavi Ji expressed thanks to the existing board for all the accomplishments and expressed sincere desire to work with the new board. She also thanked all volunteers, Pooja coordinators and devotees, and finally thanks to our both Pandit ji for their spiritual guidance. Thank you and wishing good luck to the next Board.

#### Treasurer's Report:

Mr. Chander Sethi presented Treasurer's report. He discussed the opening balance on Jan 1, 2020 and closing balance as of Nov. 30, 2020. He highlighted that we got a grant of \$25K from Maricopa county. He also apprised everyone that we got \$7,500 we are applying to Fed agency to explore if this loan can be converted into grant.

After the treasurer report presentation, Mr. Sethi asked if there was any question- no questions from floor. Mr. Sadachar appreciated the efforts of the current Board to receive the Grant from City of Phoenix.

A Motion was made by the treasure to approve the financial report, seconded by Surinder Tuli and Vaibhavi Pradhan. *Motion was approved unanimously*.
